Required insurance: The applicant will be required to submit evidence of a certificate of liability insurance with the City of Claremore as the name insured. The amount of insurance at minimum is to be equal with the Okla. Tort Liability Claims Act. \$25,000 Property Damage, \$100,000 Personal Injury, \$1,000,000 per occurrence. Ten days cancellation notice required. Insurance must be in effect beginning on the date of set-up and lasting until the removal of all equipment. Failure to abide by the guidelines and recommendations of the City of Claremore may result in the immediate termination of your permit. **(Attach a copy of insurance)**
