To All Plan Holders:

Please note the following changes and/or clarifications:

1. **CONTRACT TIME:**

The contract time listed in the bid documents was listed as 90 days. The contract time for completion is hereby changed to 120 days. Note that weather days preventing work will not count against contract time.

2. **JOINT GROUTING DETAIL:**

In areas that require joint grouting, the grout thickness down into the joint needs to be 3" minimum.

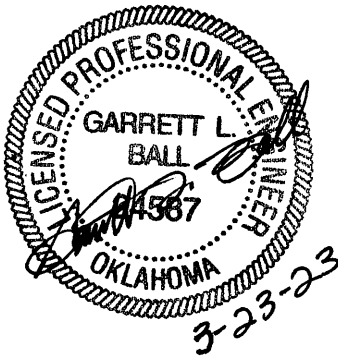
3. **BID SCHEDULE:**

- a. "FEB CLEANING" will remain in the bid schedule. This cost shall include any washout remaining after any solids (over 1" in size), saplings, rags, trash, etc. are removed. Residuals remaining after cleanout has been approved by the Engineer can be washed down the drain back to the pump station.
- b. "SLUDGE REMOVAL/HAUL OFF" has been added to the bid schedule. This cost shall include removing all solids 1" or larger, rags, trash, saplings and any other debris in the FEB that could cause a

pump clog. This material will need to be removed from the FEB and moved to the sludge drying beds north of the FEB to dry. Once dry (will be required to pass a paint filter test) the material will need to be loaded and hauled to the Waste Management Landfill at 13720 E 46<sup>th</sup> Street North, Tulsa, OK 74116. Permitting fees and tipping fees (landfill dump fees) will be paid by the City of Claremore. Payment for this item will be based on load ticket weights provided from the landfill. Payment for this item will be per ton.

- c. **REPLACE THE BID SCHEDULE IN THE BID BOOK WITH THE ATTACHED BID SCHEDULE.**

*All other terms, conditions and specifications remain unchanged. Any additions made to the Bidding and Contract Documents including the Plans and Specifications per this Addendum shall be considered a part of the original Bidding and Contract Documents. The professional seals and signatures applied to the original Bidding and Contract Documents are thereby considered to cover any additions to said documents per this Addendum.*
