Grant of Right Entry: I certify that I am the owner, or the owner's authorized agent, of the property on this application. I grant, freely and without coercion, the right of access and entry to said property to the United States Government, including but not limited to the US Army Corps of Engineers and the Federal Emergency Management Agency (FEMA), the State of Oklahoma, Oklahoma Department of Emergency Management and Homeland Security, the City of Claremore, and each of their agencies, agents, contractors, and subcontractors, for the purpose of removing and/or clearing any or all stormgenerated debris, including demolition and removal of unsafe structures, from the property on this application.

Hold Harmless: I understand that this permit is not an obligation upon the government to perform debris removal and/or demolition. I agree to indemnify and hold harmless the United States Government, the US Army Corps of Engineers, FEMA, the State of Oklahoma, Oklahoma Department of Emergency Management and Homeland Security, the City of Claremore, and any of their agencies, agents, contractors, and subcontractors, for damages of any type whatsoever, either to the property on this application or to persons situated thereon. I release, discharge, and waive any action, either legal or equitable, that might arise by reason of any action of the above entities. I will mark any sewer lines, septic tanks, water lines, and utilities located on the described property.

As further consideration for the granting of this Right of Entry, the United States Government, the US Army Corps of Engineers, FEMA, the State of Oklahoma, Oklahoma Department of Emergency Management and Homeland Security, and the City of Claremore, and any of their agencies, agents,

contractors, and subcontractors, do hereby agree to indemnify and hold me and/or the property owner harmless from damages of any type whatsoever, incurred or suffered by these entities, et al, and cause by me and/or the property owner; and these entities do expressly release, discharge and waive any action, either legal or equitable, that might arise by reason of any action or inaction by me and/or the land owner. Any acts by the above entities in furtherance of the purposes of this Right of Entry shall be deemed an acceptance of the terms of the Hold Harmless paragraph.

Duplication of Benefits: Most homeowner's insurance policies have coverage to pay for the removal of storm-generated debris and/or demolition. I understand that Federal law (42 United States Code 5155 et seq.) requires me to reimburse the Federal government, through the State of Oklahoma, Oklahoma Department of Emergency Management and Homeland Security, and the City of Claremore, the cost of removing the storm-generated debris and/or demolition to the extent covered in my insurance policy. I also understand that I must provide a copy of the proof/statement of loss from my insurance company to FEMA and the State of Oklahoma Department of Emergency Management and Homeland Security if I have received payment, or when I receive payment, for debris removal and/or demolition from my insurance company, or any other source, I agree to notify and send payment and proof/statement of loss to for final recovery by FEMA. I understand that all disaster related funding, including that for debris removal from private property is accounted for through the State of Oklahoma Department of Emergency Management and Homeland Security, and is subject to audit. I acknowledge that information submitted will be shared with other government agencies, federal and non-federal, contractors, their subcontractors, and employees for purposes of disaster relief management and for the objectives of this right of entry.

Term and Expiration: This Agreement shall be effective as of the Effective Date unless terminated earlier, the term of this Agreement shall continue in effect for a maximum of twelve (12) months from the declaration of DR 4791 which was declared on June 14th, 2024.
