ORDINANCE NO. 2025- \\

AN ORDINANCE CLOSING THAT PORTION OF THE ALLEY LYING NORTH OF AND ADJACENT TO LOTS 8, 9 AND 10 IN BLOCK 2 OF ACADEMY ADDITION, AN ADDITION TO THE CITY OF CLAREMORE, ROGERS COUNTY, OKLAHOMA, ACCORDING TO THE RECORDED PLAT THEREOF.

THE CITY OF CLAREMORE HEREBY ORDAINS:

<u>Section 1.</u> That the City of Claremore deems it necessary and expedient to close the alley lying North of and adjacent to Lots 8, 9 and 10 in Block 2 of Academy Addition, an Addition to the City of Claremore, Rogers County, Oklahoma, according to the recorded plat thereof ("Closed Alley").

- Section 2. That the franchise holders, City of Claremore, COXCOM, LLC, Oklahoma Natural Gas Company, a division of ONE Gas, Inc., Southwestern Bell Telephone Company, LLC dba AT&T Oklahoma, AT&T Enterprises, LLC fka AT&T Corp, and Cox Oklahoma Telcom, LLC or other persons having a special right or privilege granted by ordinance or legislative enactment to use the Closed Alley have either consented in writing or have not otherwise objected to the closing. There are no other franchise holders or other persons having a special right or privilege to use such Closed Alley.
- <u>Section 3.</u> That the Closed Alley was established on the original Plat of the Academy Addition filed of record June 28, 1905 under Plat #001 at the Office of the Rogers County Clerk.
- Section 4. That the alley lying North of and adjacent to Lots 8, 9 and 10 in Block 2 of Academy Addition, an Addition to the City of Claremore, Rogers County, Oklahoma, according to the recorded Plat thereof is hereby closed.
- Section 5. That the closing of the alley lying North of and adjacent to Lots 8, 9 and 10 in Block 2 of Academy Addition, an Addition to the City of Claremore, Rogers County, Oklahoma, according to the recorded Plat thereof shall not affect the right to maintain, repair, reconstruct, operate or remove utility, public service corporation or transmission company facilities or service therein.
- Section 6. In the judgment of the City Council of the City of Claremore, Oklahoma, the public peace, health, safety and welfare of the City of Claremore, Oklahoma and the inhabitants thereof demand the immediate passage of this ordinance, an emergency is hereby declared, the rules are suspended, and this ordinance shall be in full force and effect on its passage and approval.
